Welcome to the 2016 pool season! We look forward to having you as a valued member of the Lakeshore Swim Club.

Before the summer begins, the pool's Board of Directors would like to bring the following rules to your attention. Abuse of the rules, especially those specifically outlined below will result in immediate action by the Board up to and including termination of membership.

**1. The pool is for paying members and their signed in guests only.**

Please do not give your key out to non-members and remember to have your membership card during each pool visit. Members must report all guests on the sheet at the pool. Membership cards will be checked and guest fees enforced.

**2. Children under the age of 16 must be accompanied by an adult if a lifeguard is not on duty.**

Children must be picked up by the end of the lifeguard shift if no one is available to watch them thereafter.

**3. Stay safe and be respectful of the pool property.**

NO BACK DIVE.

NO ONE ALLOWED ON THE LIFEGUARD STAND except the lifeguard.

NO MISUSE OF THE POOL SLIDE.

NO MISUSE OF THE POOL CHAIRS.

NO SMOKING on the pool property.

NO SMALL ITEMS INTO POOL (i.e. sunflower seeds, bobby pins, etc.)

**4. The pool gate must be locked at all times.**

### SWIMMING POOL HOURS OF OPERATION

6:00am-12:00pm	OPEN SWIM	Except during swim lessons, if offered
12:00pm-1:00pm	POOL CLOSED	Chemical treatment and cleaning
1:00pm-5:00pm	OPEN SWIM	Lifeguard on Duty Monday-Friday
5:00pm-12:00am	OPEN SWIM	Except during private party
12:00am-6:00am	POOL CLOSED	

The pool water will occasionally be shocked with high levels of chlorine to kill the residual bacteria. When this is done, a warning sign will be posted on the gate. Swimming will be terminated until the chlorine level drops. The Topeka Police Department will be patrolling the pool during the hours from midnight to 6:00am. Anyone found on the grounds will be considered to be trespassing.

### POOL PARTIES

Private pool parties will once again be offered to members. This year the pool is available for rental as follows:

### MEMBERSHIP RECRUITMENT DISCOUNTS

Members can earn discounts towards next year's membership dues by recruiting new members or past members (who dropped their membership prior to the 2014 season). For each new membership recruited, you will receive a \$20.00 credit towards your 2017 membership fee. For each past membership renewal (those who dropped their membership in 2014), you will receive a \$10 credit towards your 2017 membership fee. Please be sure to have new recruits put your name on their membership registration form. There is no limit to discounts received, however, when club memberships reaches capacity, newly recruited members will be put on a waiting list and the discount will only be granted if a slot becomes available to them.

### **MEMBERSHIP GUIDELINES**

#### **MEMBERS:**

1. In an effort to keep non-members from using the pool, all members will be issued a new membership card and key for the 2016 pool season.

The membership card must be shown to the lifeguard upon entering the pool or available upon request of a Board Member. Admittance to the pool will be granted for those who have met these criteria.

If your membership card or key is lost or stolen, notify Secretary, Kristy VanMetre, to obtain a replacement. Replacement keys will be issued to an adult member for a \$5.00 fee.

#### **GUESTS:**

1. A non-member can be a guest one day of each calendar month without charge. A \$2.00 fee per guest will be charged on all days beyond the one-day monthly limit. He/she may not return as a guest of any other member during that month without incurring the required \$2.00 charge.

Overnight guests of a member are exempt from the one-day restriction and may swim the duration of his/her stay with the member at no charge. Please notify a member of the Board in advance with the name(s) of the overnight guest(s) and the duration of their stay.

2. A guest must be accompanied by the inviting member at all times.
3. All guest, whether subject to a fee or not, must be reported on the Guest Sheet located in the phone box at the pool. The name of the guest(s) and member must be reported. The cooperation of the member is required to avoid abuse of guest privileges. Members will be billed for guest fees and these fees must be paid prior to renewing their membership for next year.

Exception: If guest fees for a member reach \$20.00 at any time during the swim season, the member will be billed and the fees will be due immediately.

4. Guests will be limited to five (5) people per membership at any given time. For larger groups, please contact Event Coordinator, Mindy DeLorge, to discuss a private pool reservation.

**ALL KNOWN ABUSE OF GUEST RULES SHOULD BE REPORTED TO A MEMBER OF THE BOARD OF DIRECTORS.**

#### **DAYCARE\BABYSITTERS:**

1. A member daycare provider bringing non-member children or a non-member babysitter with member's children are allowed to bring those and/or other children in their care to the pool during the hours the lifeguard is on duty in accordance with the following guidelines:

- a. Pay \$50.00 per season for non-member baby-sitter or \$50.00 per non-member child.
  - b. The daycare\babysitter must supervise the children in their care while at the pool.
  - c. Identify in writing the names of the non-members on the attached registration form.
  - d. Health Form for each child.
2. During lifeguard hours children less than 8 years of age must be accompanied by a babysitter at least 16 years old. Children 8 years old and over must be accompanied by a babysitter at least 13 years old.

Any child or babysitter under the age of 18 must leave the pool after the lifeguard's shift if an adult member (18 years or older) is not available to watch them.

### **SWIMMING POOL RULES**

It is the responsibility of each and every member to see that the rules are followed. This is not only your right, but also your obligation. Inform someone if they are breaking a rule or notify your Board of Directors. By doing this, we can all have a safe and enjoyable summer.

Violation of the rules set forth herein and other rules, as may be dictated by common sense, will be warned by the lifeguard verbally or by short blasts from the lifeguard's whistle. Violation from the same offender will be cause for the lifeguard to impose a sit-out or suspension of pool use for a period not to exceed three days. Serious and/or repeated violation of the rules herein will be reported to the Board of Directors for disposition.

### **BOARD OF DIRECTORS DISCIPLINARY ACTION FOR VIOLATION OF POOL RULES**

First occurrence	A verbal notice will be issued to the pool member.
Second occurrence	A written notice will be sent to the pool member.
Third occurrence	Family membership will be suspended pending board review.
Major violation	Immediate suspension or termination of membership. Suspension or termination of membership will not warrant any refund of membership dues.

1. No back dives permitted.
2. The lifeguard will be in charge of the swimming pool and the areas adjacent thereto. The authority and responsibility for enforcing the rules and requirements herein set forth and for such other actions as may be necessary to protect life and property is vested with the lifeguard. In extreme cases, the lifeguard may call upon a member of the Board of Directors in enforcing the rules herein established.
3. You are required to show your membership card to the lifeguard upon entering the pool area.
4. Alcohol in any form is banned on pool property.
5. Smoking is banned on pool property.
6. Swimming alone is not permitted under any circumstances.
7. If a lifeguard is not on duty children 8 years and under must be accompanied by an adult member (18 years or older) at all times while the child is in the pool or pool compound (Refer to item #2 under "Babysitter" membership guidelines for required babysitter age while lifeguard is on duty).

8. Members and guests under the age of 18 are not permitted in the pool or pool compound unless they are accompanied by an adult member of the pool, during the hours when the lifeguard is off duty.
9. The pool will be closed by the lifeguard or any member of the Board of Directors at such times that the health and welfare of swimmers is believed to be in jeopardy.
10. Non-swimmers will not be permitted in deep water or areas adjacent to the deep end of the pool. Beginning swimmers will be permitted in the deep water only after permission is obtained from the lifeguard.
11. The lifeguard will take a 10 minute break every hour and will require all minors to clear the pool during breaks for adult swimming only.
12. Glass bottles and other breakable and dangerous items will not be allowed in the pool area or pool compound.
13. All members are expected to clean up after themselves. This includes picking up cans, wrappers, pool accessories, etc.
14. Chewing gum or sunflower seeds will not be permitted in the pool or pool compound.
15. Hanging onto, or otherwise stretching marker ropes, is prohibited.
16. Use of artificial or air inflated swimming aides will be restricted to use in the shallow end of the pool, except at the discretion of the lifeguard. During the hours when the lifeguard is off duty, use of such aids is permitted in the deep end. Horseplay on such swimming aids is prohibited at all times. Only "nerfball" type balls are permitted. No tennis balls or rubber balls are permitted in the pool.
17. Pets will not be permitted in the pool or pool compound.
18. Careless acts and horseplay are not permitted in the pool or pool compound, including "chicken fighting" and "dunking".
19. Running is expressly prohibited.
20. Diving will be permitted in the deep end only.
21. No one is allowed on the lifeguard stand except the lifeguard.
22. Swimming under the slide is prohibited.
23. Only one person at a time is permitted on the slide. The next slider must wait until the previous person's head is above water before sliding. Failure to adhere to this regulation will result in temporary suspension of use of the slide by the lifeguard.
24. The use of profane, vulgar or obscene language and gestures is expressly prohibited.
25. Any individual displaying visible signs of intoxication will not be permitted in the pool.
26. Only upon the specific request of the lifeguard will swimmers assist in the rescue operations. Under no circumstances will swimmers interfere with the lifeguard or a victim while rescue operations are being conducted.

27. Only proper swim wear will be permitted in the pool. Cut-offs or street clothing of any kind will not be permitted in the pool. Children still in diapers are required to wear "Little Swimmers" when in the pool. NO DIAPERS ALLOWED.
